1. General description

Planar passivated four quadrant triac in a SOT78 (TO-220AB) plastic package intended for use in general purpose bidirectional switching and phase control applications. 




Fig. 1. RMS on-state current as a function of mounting base temperature; maximum values

Fig. 2. RMS on-state current as a function of surge duration; maximum values










Fig. 6. Transient thermal impedance from junction to mounting base as a function of pulse width



Fig. 7. Normalized gate trigger current as a function of junction temperature




Fig. 8. Normalized latching current as a function of junction temperature





Fig. 9. Normalized holding current as a function of junction temperature





Fig. 11. Normalized gate trigger voltage as a function of junction temperature
